ANTICIPATING AND AVOIDING VIOLENCE IN THE WORKPLACE: DON'T BECOME A HEADLINE

Five hundred people may lose their lives as the result of violence in the workplace during 2017. As many as 150,000 nonfatal injuries may be attributable to workplace violence during the same interval. Up to 500, 000 violent crimes against persons in the workplace can also be anticipated. These sobering projections magnify the potential threat and motivate development of intervention strategies. The entire work environment requires evaluation in the light of such prospects, as employers seek to reduce the risk that a given location will become the location of a workplace disaster.

Substantial effort has been devoted to the reduction of workplace violence. Multiple studies consider the purported causes of violent events, as well as mechanisms calculated to alleviate future harms and reduce the impact of injuries. A survey of such efforts may help emphasize the necessity of contemplating multiple social, political and economic factors crucial to the assessment and anticipation of potential outbursts. Multiple tactics and techniques were developed to reduce or eliminate the risk of harm. This program will review such efforts for the employer who seeks to reduce the risk of violence in their workplace.
