PLENARY SESSION:

Recognizing and Mitigating Cyber Security Risks in the Design and Construction Industry

While all businesses face cybersecurity risks, the design and construction industry is confronted with heightened risk due to the ever-increasing use of computer technology and linked devices. The volume of stored data and points of access to that data render design and construction firms rich targets for incursion. So too, the inherent fluidity of the construction labor force is viewed as a unique security risk. The massive data breach incurred by Target was initiated through a phishing email sent to a mechanical contractor that was a vendor for Target. In Germany, hackers gained access to the production network of a steel mill, where they compromised the control systems resulting in a blast furnace not being able to be properly shut down. This panel, including nationally recognized cyber security expert Jake Kouns, will discuss current and emerging cyber risks confronting the design and construction industry and strategies for risk mitigation.


