IS YOUR EMPLOYER WELLNESS PROGRAM LEGAL?

Employer Wellness Programs are a very popular benefit to offer to employees and can be designed in many different unique and innovative ways in order to improve employee health and morale. However, these wellness programs create a variety of legal issues including the legality of financial incentives, privacy concerns and the potential to violate certain discrimination laws. The DOL, EEOC, IRS and HHS each have a role in overseeing the legal requirements provided through a number of federal laws including HIPAA, ACA, ADA, and GINA. To further complicate designing a program that is legal, this array of compliance rules can overlap, conflict, or be ambiguous and are changing frequently. This session will review the current legal requirements that employers should be following.

In recognition of her lifetime contributions to the legal profession, she has been elected a Fellow of both the American Bar Foundation and the College of Law Practice Management.

CHRISTEN C. BLACKBURN is a shareholder with ALFA International member firm Lewis Thomason in Nashville, Tennessee.
