9.00 – 12.00: Guided Tour of Plaza de Mayo, San Telmo & La Boca, Buenos Aires



The bus will depart from the hotel and take the participants on to Plaza de Mayo, San Telmo and the La Boca neighborhood.
Participants will walk the famous Plaza de Mayo and the Buenos Aires Cathedral (including the tomb of General José de

San Martin). Then walk to the oldest neighborhood in the city of Buenos Aires, San Telmo which includes pop-up art galleries, old churches (e.g. San Pedro Telmo), museums, food halls and stalls, antique stores and a semi-permanent antique fair (Feria de Antigüedades) in the main public square, Plaza Dorrego. Finally, participants will visit the famous Caminito, in La Boca neighborhood.

## SPEAKER BIOS

FERNANDO BADESSICH is a partner at Finanzas & Gestion (F&G), one of the premium financial boutiques in Argentina, specialized in providing advisory services to companies, institutions and individuals, local and foreign, in mergers and acquisitions, financing, liability management and debt restructuring. F&G has worked with clients in Argentina, Ecuador, Venezuela, Peru and Chile.Mr. Badessich graduated in 1989 as an Economist from the Faculty of Economic Sciences at the University of Buenos Aires (UBA), and has obtained a master's degree in business administration (MBA Program) at the Massachusetts Institute of Technology (MIT Sloan School of Management - 1994). After graduation he worked as a financial consultant for Salomon Brothers Inc. in its corporate finance department for Latin America, where he actively participated in advising governments on privatizations (Panama, Dominican Republic, Venezuela, Argentina and Colombia), issuance of share capital for companies (Banco Ganadero, Laboratorios Chile, Compañías Cerveceras Unidas de Chile, Siderar), structuring and placement of debt instruments (Bonos 144a, Yankee, structured, convertible), advice on mergers and acquisitions (Rio de Janeiro Refrescos, Kaiser Aluminum, Banco Bilbao Vizcaya, Bristol Myers Squibb) and a large number of financial transactions. In 1997, Mr. Badessich returned to Argentina as a representative of NationsBank, then the fifth largest bank in the United States, which later merged with Bank of America, where Mr. Badessich assumed the general coordination of the bank's corporate and investment banking businesses, a position he held until early 2004. Mr. Badessich also served as director of the American Chamber of Commerce in Argentina (AmCham), in the Council of the Americas, within the MIT Club of Argentina, and in other business and cultural institutions.

JESSICA ZAROSKI BAUER joined ALFA International (ALFAI) in 2004 as a Coordinator of Events & Member Services. She then worked for several years as a Marketing Manager, Chief Events Officer and Chief Operating Officer. After 17 years with the association, she accepted her current role as Chief Executive Officer. In this position she is the strategic thought leader of the organization, working closely with the Board of Directors and the various ALFAI committees. She manages headquarters staff and maintains constant communication with association members. Jessica oversees the member recruitment, development and retention programs as well as the marketing and business development initiatives for the organization. Prior to joining ALFA International, she worked in the marketing department of the Chicago-based law firm of Gardner, Carton & Douglas, LLP (now Faegre Drinker Biddle & Reath). She is a graduate of the University of Iowa Tippie College of Business (Go Hawkeyes!) and is an avid college football fan. He has been chief economist for Argentina at BTG Pactual since March 2014 until April 2020 (deputy chairman from 2016 until 2020). Between 2001 and 2014 he was South American economist at the British Embassy in Buenos Aires, covering Spanish Speaking South American countries. He was also a member of the Cooperation committee, which funded projects in partnership with different areas of the Argentine government and relevant NGOs. He has acted as deputy press officer. Andres is professor at the Economic School of the University of Buenos Aires and at Universidad Torcuato Di Tella. Andres is at an advisor to the Board of Banco de la Nación Argentina and a member of the advisory committee at Llorente y Cuenca. His Podcast "La Economía en 3 minutos" is listened for over 1,800 people every week and has been ranked #1 in Apple Podcast's chart. He published in 2023 the book "Puede Fallar" on the communication of economic policy (co-authored with Gabriel Llorens Rocha).

ROBERTO CHUTE is a Partner and Head of Latin America Private Markets investments. He is based in Buenos Aires. Mr. Chute leads TRG private markets investments in Latin America across a wide range of sectors including pharmaceutical, information technology, logistics, agribusiness, real estate, consumer products, retail, and mining services, among others. Mr. Chute has over 20 years of private equity investing in Latin America and serves on the Board of Directors of several portfolio companies in the region. Mr. Chute experience spans across different capital structures such as buy-outs, growth capital and mezzanine investments. Prior to joining TRG in 2006, Mr. Chute was a Principal at Banc of America Equity Partners Latin



America (BAEP). During his tenure at BAEP, Mr. Chute was responsible of investments in Mexico, Brazil and Argentina and served as Director of the Board on several portfolio companies in the retail, telecommunications, outdoor advertising, consumer finance and waste management sectors. Mr. Chute also worked in the investment banking division of Goldman Sachs and previously worked as a senior associate at Strat Management Consulting, a top management consulting firm in Argentina. Mr. Chute began his career at the Techint Group in Buenos Aires.Mr. Chute received his MBA from the Kellogg Graduate School of Management at Northwestern University and a degree in Industrial Engineering from the Instituto Tecnológico de Buenos Aires, Argentina. He is fluent in Spanish and English.

PABLO F. FERRARO-MILA is one of the founding partners of GFM Abogados in Buenos Aires, Argentina. Pablo specializes in Mergers and Acquisitions, Corporate Law and Project Finance, Engineering and Construction Projects and International Business Transactions. Before forming GFM in 2005, he was a partner with a major law firm in Argentina and had worked with Cravath, Swaine & Moore in New York and with Allen & Overy in London. He is also a frequent contributor to specialized publications and author of the book "The Transfer of Control Shareholdings", published by LexisNexis. He is an active member of the American Bar Association and of the International Division of The Law Society of England and Wales. In addition to his native Spanish, he is fluent in English, French and Portuguese.
