The “Abc’s” of Digital Forensic Investigation

This panel will provide a practical overview of how cell phone data can be used to evaluate and verify claims in a variety of disputes. Understanding the Numbers—Case Law and Legislative Updates on Prop 22 and Section 230

This panel will review and analyze recent case law and legislative actions related to Prop 22 litigation in California and Section 230 of the Communications Decency Act of 1996. Calls for reforming Section 230 continued to gain steam in 2025 with several legislative repeal efforts being pursued in Congress. However, federal courts continue to broadly enforce its liability protections. The panel will discuss the status of current Section 230 repeal efforts and the most recent case law interpreting the scope of Section 230 liability protections for platforms in the past year.

**Swiped, Booked, or Delivered—
and Then Harmed: Product Liability in
the Age of Platform Commerce**

This presentation examines a landmark 2025 Missouri appellate decision and its significant implications for how courts treat rideshare and gig economy applications under product liability law. The Missouri Appellate Court established a new two-part framework: (1) a mobile app can qualify as a product if the facts alleged show sufficient similarities to a tangible product; and (2) the plaintiff must allege the harm resulted from a defect in the app itself—its design or functionality—rather than from the company’s broader business model or services.

The Broader Implications: The presentation walks through what this ruling means going forward—including potential direct liability against Gig Economy and Technology companies facilitated by alleged platform design failures. It also surveys similar holdings from Kansas, California, Texas, and Florida, as well as contrasting decisions, and reviews how Illinois, Washington, and Texas courts have approached these issues.

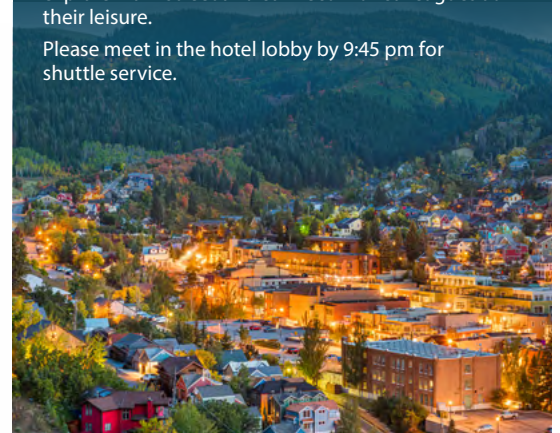
