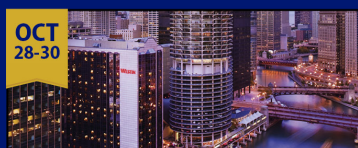

## Gold Sponsorship - \$27,500/year

- Participation in four (4) ALFA International PG client-focused seminars, including:
  - Two (2) full registrations per seminar include all networking meals and receptions.
