	Federal and state law typically empowers companies to facilitate arbitration as an effective alternative to civil proceedings. The Gig Economy Coalition has already coordinated efforts to build positive case law in challenging jurisdictions, shaping aspects of this ever-changing space for the greater benefit of the industry.
