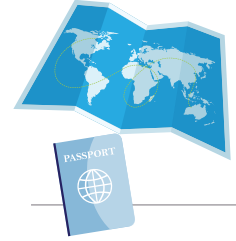

• BREAKOUT 1 • Cross-border Contracts—Getting dispute resolution clauses right

For many of us, cross-border transactions are an everyday part of business. While no one wants a deal to go wrong, as inhouse counsel and outside counsel, we need to ensure contracts contain provisions that effectively address resolution of disputes that may arise. It is a major mistake to think of these provisions as “boiler plate”. Dispute resolution provisions need to be carefully considered in the context of a particular transaction, the parties to that transaction and the jurisdictions in which they are operating. Clear drafting and appropriate terms can mean the difference between effective resolution of disputes and major, expensive and time wasting fights.

This session will address key issues to consider in choosing effective dispute resolution processes and the drafting of appropriate contractual terms.

• BREAKOUT 2 • Litigation Cost Control: Identifying and Managing the Hidden (and not so Hidden) Internal Costs of Litigation

Litigation often means outside counsel – which means legal bills. However, legal bills are not the only costs of litigation to an organization. Litigation can cost much more than what legal bills reflect. There is the cost of time and loss of talent when employees are pulled away from their regular duties to gather documents or prepare for depositions, the cost of the internal rumor mill, and many other often overlooked “costs.” During this session we will identify some of those hidden, and perhaps not so hidden but often overlooked, costs and more importantly, discuss how to limit those costs. In-house counsel will walk away from this session with ideas to limit internal disruptions and control the hidden costs before they spiral out of control – while still providing outside counsel what they need to defend your company. Outside counsel will leave with a new appreciation of the challenges faced by in-house counsel and a blueprint to be a true partner with your client.

• BREAKOUT 4 • Navigating Tariffs - Legal Strategies for a Shifting Global Trade Landscape

2025 was a year of significant shifts in the global trade landscape, chiefly influenced by the effects of global tariffs implemented by the Trump administration in the United States, as well as reciprocal tariffs implemented by countries impacted by the U.S. tariffs. The effects of these tariffs on corporations involved in global trade are multi-faceted. Tariffs lead to increased and unforeseen costs, a detrimental effect on profit margins, and increased exposure to risk and the potential for legal action if tariff-related risks are not handled properly. This panel will provide an update on the pivotal cases Learning Resources v. Trump and Trump v. V.O.S. Selection, both of which are anticipated to be ruled upon by the U.S. Supreme Court as of the seminar, as well as review how business have been navigating the tariffs of 2025 and may strategically look to mitigate the effects of tariffs in the future.

The increasing ease and use of electronic payments and payments induced by electronic communications such as email provide opportunities for fraudsters and scammers to exploit these technologies. • ROUNDTABLE 3 • Cross-border Contracts—Enforcing and Collecting on Contractual Promises

In follow-up to the Getting The Dispute Clause Right panel, this roundtable addresses real-world issues and challenges when enforcing even the most well-considered dispute resolution provision. The best written contract remains merely a set of promises the law lets you sue to enforce. And it is the judge, arbitrator(s), or jurors who ultimately decide the meaning of each contractual provision, not the parties. These practical realities are doubly present when the venue is outside your company’s typical experience, or when a judgment must be enforced in a separate venue (or multiple venues). Enforcement in an unanticipated venue inevitably faces nuances, such as “magic language” of finality, among other issues such as local bias, collateral challenges based on local law, or apathy toward enforcement. Careful drafting can avoid many issues, but in cross-border transactions your company must understand and be ready to persevere through each venue’s idiosyncrasies.



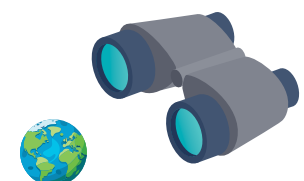
