FROM TANGIBLE GOODS TO DIGITAL CODE: THE EXPANDING SCOPE OF PRODUCT LIABILITY

In many jurisdictions, product liability law has traditionally been limited to tangible goods. That boundary is now being tested. In a recent appellate decision, a court allowed a wrongful death claim to proceed against a rideshare company, concluding that a mobile application could qualify as a “product” for purposes of product liability law.

This session examines how courts across the country are rethinking what constitutes a product in an increasingly digital economy. We will explore emerging trends, highlight key decisions from multiple jurisdictions, and discuss the implications for companies whose offerings blend software, services, and traditional products.

Product Enhancements in the Age of Nuclear Verdicts

Outside of the litigation context, product enhancements are almost universally considered beneficial. They may provide improved features or safety for customers, may allow consumers to purchase less expensive models, and can help to differentiate a manufacturer's products from competitor products. But product enhancements can also provide talking points - or worse - for plaintiff lawyers, who often argue that manufacturers should have implemented enhancements more quickly, universally, or both. Panelists will discuss discovery and trial strategies that mitigate typical arguments from plaintiffs about product enhancement timing or implementation across a product line.
